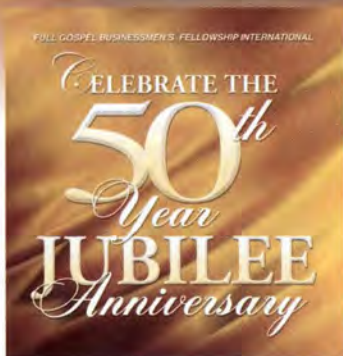

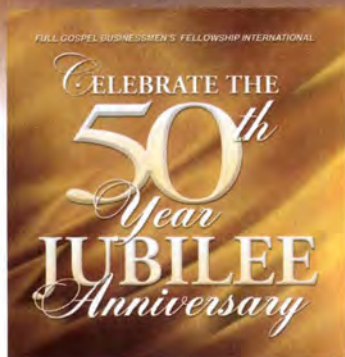

A DREAM

In August of 1980, a slightly beaten-up 1969 red Javelin drove onto the Oral Roberts University campus. My car struggled under the weight of its U-Haul trailer. In fact, it was nothing short of a miracle that the vehicle has successfully made the long trip from Wisconsin.

Excited to get enrolled, this 28-year-old unfolded myself from the small car and found my way to the admissions office. It is almost hilarious when I think of my first

introduction to the ORU campus. What a sight to behold.

My full beard, mustache, shorts, T-shirt, and sandals must have caused me to stick out like a sore thumb from the typical, formally-dressed ORU students that walked the campus that day. I remember that I was literally greeted on the sidewalk to the admissions office by an unknown student who curiously inquired as to who "I was." Worn out by the long trip

and dressed like I was, I must have been quite a sight. After I told him my name and proudly explained that I was a new law student, the student kindly asked me to sit down and handed me the student handbook.

"Didn't anyone explain that we have a dress code and hair code around here?" asked the student. He did his best to be polite, but discreetly directed me to the nearest barbershop. Only five

minutes on campus and I had already raised some eyebrows.

I was not the average ORU student. For one, I was six or seven years older than the typical new law student. Though my parents always helped pay my basic tuition, I had interrupted my college career on more than one occasion to work as a laborer, tree trimmer, carpenter, or cement mason, taking most any job that would help pay my living expenses, providing a new experience and offer a temporary detour from the routine school schedule.

My undergraduate degree was also lengthened by a long trip to South America. I spent nearly a year attending Escuela de Idimoas - Padres de Santiago Apostol, a Spanish language school in Lima, Peru. There I worked with my brother, a Catholic priest, to provide healthcare, education and food supplies to Peruvian Indians in the Amazon Basin and Quechua Indians of the Peruvian Andes.

A second characteristic that separated me from the average ORU student was that I was neither Protestant nor charismatic. I had been raised Catholic,

attending a parochial school, going to daily mass and even serving as an altar boy in my youth. Though I grew up in this religious environment and had been taught about God from my parents, it wasn't until college that I developed a personal relationship with Jesus Christ.

Armed with my new personal faith, I chose ORU because my parents and I were both convinced that the new O.W. Cogburn School of Law would teach the law from a biblical perspective. My friends had argued that the law school wasn't even accredited and they suggested that I attend one of the more prestigious schools that had accepted me. However, the decision seemed right to me. I never doubted that God wanted me at ORU.

I had always dreamed of being a lawyer. As a small boy, I had built a model of what my future law office would look like. After I graduated from law school, I went to work as a legal intern in the Tulsa County District Attorney's Office, and began to study for the bar exam. I felt like I was fulfilling a life-long dream.

From my first day on the job, I

loved public practice. I enjoyed working in the courtroom and felt immediately at home as a prosecutor. Though I never got involved with all the protests that went on during the late sixties and early seventies, the period did challenge me to someday enter public service and attempt to find a better way. I had always been the “Father Confessor” type with people coming to me asking me to help them fix their problems. Being a prosecutor fit perfectly into my personality. We are often thought of as the good guys, the

people that are expected to wield the sword and wear the white hat. I love public service and cannot imagine doing anything else!

In 1995, when District Attorney David Moss tragically died, the governor appointed Bill LaFortune to fill that position for the remainder of the term of office. I remained with the office as the Director of Crimes against Children. In 1998, Bill LaFortune resigned from the office of District Attorney and Chuck Richardson was appointed by the governor to finish out the term of office.

In 1998, with my career as a prosecutor at full force, I had my own candidate in mind; and I unexpectedly entered the race.

My friends thought I was crazy to run. No one knew my name. I didn't have much financial support, nor an army of supporters that were ready to help me. I didn't really stand a chance. Everyone knew that, but me!

By the world's standards, there was no way that I could win! Without the resources and support, I could only look to God to be my source of hope and encouragement. I was running to win, but had no inkling that I would succeed. But I knew God would use the journey to teach me something important, as often the journey is more important than the destination. As the underdog candidate, I worked hard and aggressively asked people to elect me to the job. As election day got closer, my campaign picked up more and more momentum. Weeks of hard work later, in a truly miraculous grassroots effort, I was elected as Tulsa County District Attorney.

My oath is more than a pledge to the citizens of Tulsa County, but rather is also a binding oath

to God. It is something that I could never take lightly and it carries a terrific responsibility. I take my faith and personal beliefs very seriously, but it is extremely important to me that everyone understands that when I took that oath to ensure the public safety of everyone, no matter their political, racial, or religious beliefs.

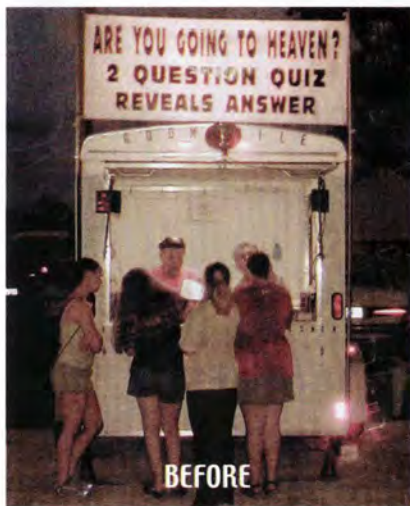
The job of District Attorney has forced me to grow both professionally and spiritually. The stress of the daily schedule has taught me the importance of studying the Bible. It is where God reveals knowledge to us.

I've learned many lessons since receiving that haircut on that first day I arrived in Tulsa. As the ORU student groomed me to meet the standards of the 1980 campus, little did he know that God would someday turn me into a leader within the community.

We serve a God that is able to take even the biggest underdog and turn him into a daily reminder that God is in charge and has all things under His control. ♦

TOTALLY OVERHAULED BY GOD

Stan Hoerman, Kansas

During a 30-day fast, God totally overhauled me. It was like spending 30 days in the Wilderness with the Lord. He purged me and cleansed me. I prayed, "I don't care. I just want to do your will." From then on, my purpose for life was absolutely changed.

You see, I was raised in a godly home with nine kids. I grew up working ever since I was old enough to pick up a hammer.

Even though I learned how to work, my father was more concerned about our spiritual development. We were a good Lutheran family. However, we'd go to other churches for Sunday night services.

We had a revival one summer; and at the age of nine, I prayed the sinner's prayer and accepted the Lord Jesus Christ as my personal Savior. I thank God for godly parents. A lot of my

parent's friends prayed that I would become a preacher. They soon gave up hope when I went to college; then joined the Marine Corp. They thought all was lost. I just lived a regular life, as a Lutheran and ex-Marine.

I had the all-American dream of get rich and retire by the age of

40. In order to accomplish that, I started to buy rental properties. I wanted to build my rental empire. I borrowed money against my coin collection, enough to make a down payment on my first apartment house. Then I got a second mortgage on that to make the down payment on the second apartment house, etc. So on my

way to achieving my “rental empire”, I got \$150,000 in debt.

I moved into one of my apartment houses. I rented one apartment to the “Jesus people”, who lived right below where I lived. They put me on top of the “Ten Most Wanted Prayer List”. They could see that the landlord was religious and went to church every Sunday. By then, I was on the Church Council, in charge of the ushers at the second service, on the finance committee too. They invited me to a Mayor’s Prayer breakfast. After that, the leader of the group said, “Why don’t you come down to our apartment, I want to talk to you.” He shared many things with me.

He convinced me to go to some of the Jesus People Meetings. One of the words given over me was that I was going to spend 30 days in the Wilderness with the Lord. I had just learned about fasting, so that’s when I fasted for 30 days and God overhauled me.

I simply fell in love with Jesus! He simply baptized me in the Holy Spirit. I began weeping. I didn’t know what had happened. I received that joy unspeakable

and full of glory. I had that silly grin on my face all of the time. Flowers were more beautiful; the sky was bluer, etc. When Jesus baptizes you in the Holy Spirit, you are a different person. All things become new.

I was excited, serving the Lord. This Catholic nun called me to give my testimony about fasting for 30 days at the Catholic High School in the religion class. She said, “Stan Hoerman, your name has been given to give your testimony in our religion class. Would you consider?” My response was, “Yes, I think that is what the Lord would have me to do.” She thought if the Lord had to tell me what to do, I had to be a weirdo of some kind.

There I was, a charismatic Lutheran teaching about fasting in a Catholic high school, with the principal’s blessing! As somewhat of a hippie, I had long hair, with a great big cross hanging around my neck. This nun, Sister Rose Marie, quite frankly, was embarrassed by the way I looked.

I shared freely and openly. In between classes, I went up to this Catholic nun and put my arm

around her and said, "Sister Rose Marie, are you saved?" Still in shock, she responded, "Of course I am saved. I am a Catholic!"

When I started talking about the Baptism of the Holy Spirit, she knew I was going too far. She moved away, yet I corresponded with her. Again, her response, "You are not converting this Catholic nun!"

We again met and I insisted, "I know what your problem is. You don't know the Lord Jesus Christ!" I hugged her and actually kissed her right on the lips. From that point on, she began to listen to what I was saying! At Christmas time, I led her through the sinner's prayer; and she gave her heart to Jesus. She eventually left the Convent; and we got married in the Lutheran Church. I don't care what church you belong to, as long as you belong to Jesus Christ, you will stand! And God can totally overhaul you! ♦

I was raised in an atheist home. But my mom was born a Lutheran, you know, if you are good and nice, you will go to heaven. I was born to learn how to earn money as fast as possible. You just have to make the money. I grew up in a family business of house construction and a marina with shipyard. We were exporting log cabins for the whole world. I was working too much, seven days a week, sometimes 18 hours a day. I never saw my wife. I was almost living in the factory.

One day I started to feel real sick. I started throwing up blood; so I went to the doctor. He told me that I had to stop work or else I would die. But the Japanese, Germans, British, and others were waiting for their houses, so I had to work.

My wife suddenly announced to me, "You are going to have to stay at home tonight, because I have to go to meet some friends at a small home church, a small weekly Bible study." I agreed to stay at home.

After one month I said, "I have to come with you and see what you are doing there." The Lord called me to Himself when I was 12, but I didn't have any Christian friends, so I left the church. When you are making money and driving around the world, you have no time for Jesus. When I came to this meeting, I just felt like I had come home. I said, "Jesus, I have lived all my life, now I will follow You." I received Jesus Christ into my heart in these meetings. After the first meeting, my father told me to come to another family meeting with my mother and brother also. They told me that these Christian people were

dangerous and they just wanted our money. My dad warned me, "You cannot go there." But I told him, "I had met Jesus; and that is all I want!" My dad was disappointed in me.

In these six years of the Bible study, the Holy Spirit was very strong. I learned to trust in Jesus, not just in church or systems. You must have the Holy Spirit to get all that the Lord has for you. God completely changed me during these years. I received a whole new life. After one year after I was saved, I was reading my Bible that if you got baptized, you would be a new babe in Christ. I had diabetes at this time.

I said to Jesus, "When I get baptized, I have to be healed." So, it was late in November, just before the ice came on the water, we drove to the ocean. I was baptized in the ocean on Sunday evening at 10 p.m. in the ice water. Instantly, I was completely healed of diabetes. I can now eat cookies and cakes, everything without any problem. The Lord is marvelous!

After I got healed, I read in the Bible about Jesus as my Healer and about many healings in the Bible. Healing is an ongoing part of my life. I teach about healing to many people. Jesus will heal us in everything, if we just trust in Him.

Jesus also spoke to my wife when she developed cancer. She came home and said, "Why should we worry, we have Jesus!" So she started to pray and worship the Lord. The next time she went to the hospital, she was completely healed.

In the Spring of 2002, I received a prophetic word, "You have to kick off all the chains since you were born. You have to turn and go a new way. You are like Gideon; you should take the new land." When I came home, I told my brother that the Lord had spoken and that he could take all of the business, everything. I had been in the family business since I was born. My brother and father thought I was crazy because I turned my face away from all of the money, etc. But I said,

“I will have nothing.” But because God is so faithful, I have more money in my pocket now, than before. It is tremendous!

I read “the Happiest People on the Earth” Book. I found it in a Christian bookstore in Norway. I said to myself, “When I find this Fellowship, I will be a member.” I signed up as a member right after I found the fellowship that I had to be in. I started going to go to the Fredrikstal Chapter meeting. I began to view Christians in another way. Methodists, Baptists, Lutherans, etc. could worship together at FGBMFI. They also had the Holy Spirit and they were speaking in tongues.

Two years ago, the leadership asked me to be the National President for FGBMFI in Norway. I said to them, “I have to go home and ask the Lord.” The Lord said, “I have already told you that you should do that!”

When I came into the Fellowship, the fellowship was merely a “gentleman’s club”. The Lord told me that He had to change it. FGBMFI and the Christian in Norway were “in winter; and they were freezing to death.” But now it was time for “the springtime and the summer.” We have worked hard in Norway to turn the FGBMFI in a new direction and to be more effective. ♦

THE PROMISE!

I was saved in the eighth grade. I went to a small country school, where all I did was fight. I also went to a country church. I can still feel that same pull that I felt when I was in the eighth grade, of sensing God's presence. God took all the "fight" out of me. In fact, after God saved me, I invited that boy I would always fight with, to Sunday School.

About 40 years ago at Clifton's Cafeteria, I remember Demos pointing me out. He gave me this promise, "God will do a work in and through your life! You will be a blessing to the Body of Christ, to the Shakarian family, and in the last day revival!" I have not been back to Clifton's Cafeteria since (until the 50th celebration in December, 2002).

I had been involved in FGBMFI in 1960. God is preparing His

people to minister. You are going to see phenomenal things happen in the entire Body of Christ; and FGBMFI will spearhead that. That is what the promise involves.

When I came into contact with FGBMFI, God began to speak to me about His ministry and my position in His body. Three years ago I was in Richard Shakarian's office. Matthew, my only son, promised me he would come to the 50th celebration to receive prayer. Since that time, he went ahead and finished his college degree in Denver. He met his fiancée (now wife) Kristina.

Even after he decided to come, circumstances worked against us. My heart rejoices over what God
